Therefore, the installation of a qualifying solar energy system will not result in either an increase or a decrease in the assessment of the existing property. 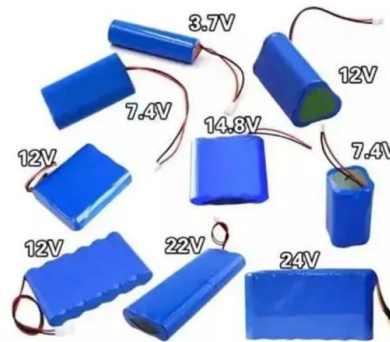

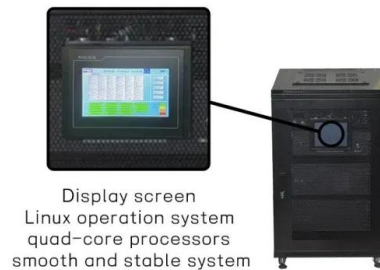
