When you Safe Harbor in 2025, your project is protected until the end of 2029. If you wait until 2026, that extends to 2030, but by then, FEOC rules will already be in force. A major change is coming for commercial solar projects — and it could determine whether your company qualifies for the federal 30% Investment Tax Credit (ITC) for solar or loses it entirely. Tariffs, foreign content restrictions, and antidumping and countervailing duty investigations have reshaped the landscape for imports of solar components and manufactured products. 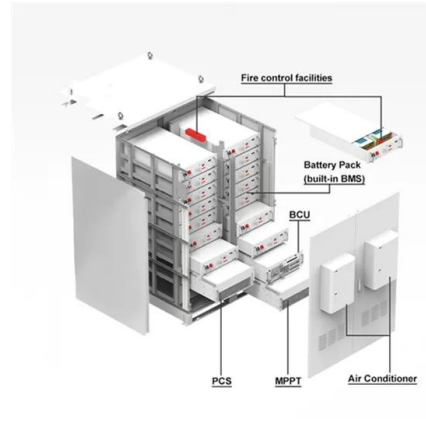
