Overview

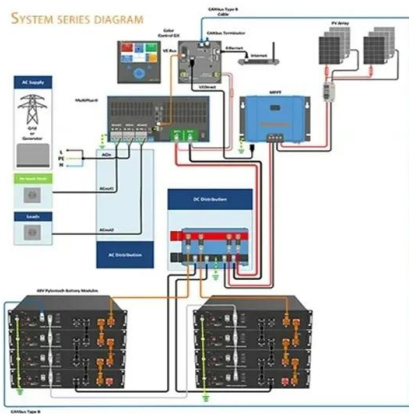
