Overview

In this article, we will outline both federal and state rules, permitting requirements, interconnection pre-requisites, and why these regulations are important to understand for both developers and landowners alike. It is important to understand the policy landscape early in your development process. On August 15, 2025, the Internal Revenue Service (“IRS”) issued Notice 2025-42 (the “New Guidance”) providing guidance on the “beginning of construction” requirements for solar and wind projects to qualify for clean electricity production credits under Section 45Y (“Clean Electricity Production”). Although solar developers can see these policies as bureaucratic red tape, they are essential frameworks that guide safe and lawful solar installation. From innovative battery technologies to intelligent energy management systems, these solutions are.

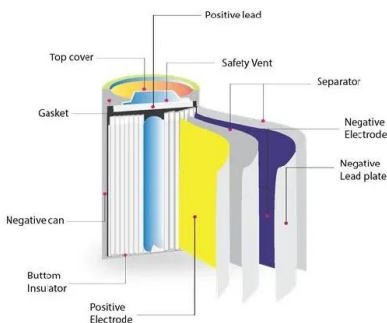

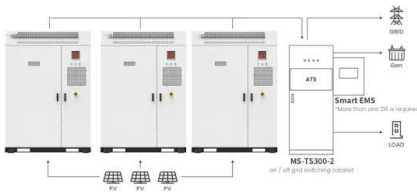
