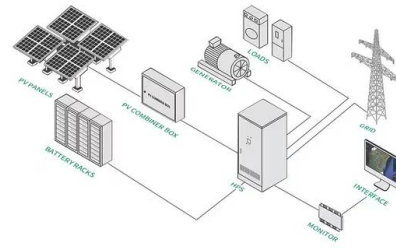

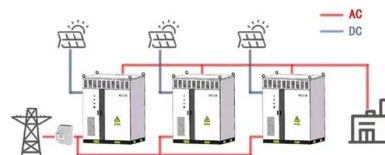
"Prices of" vs "prices for"
