

Solar container anti-dumping





Overview

The countervailing and anti-dumping duties are in addition to existing section 201 solar tariffs that are currently 14%, but are scheduled to end on February 6, 2026, and to "reciprocal" tariffs that took effect on April 5, 2025 at a 10% rate and are scheduled to increase to 46%. 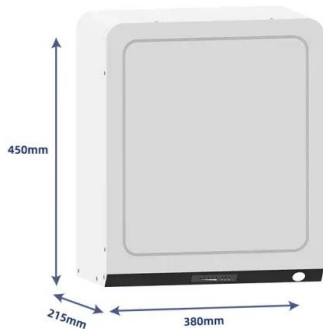

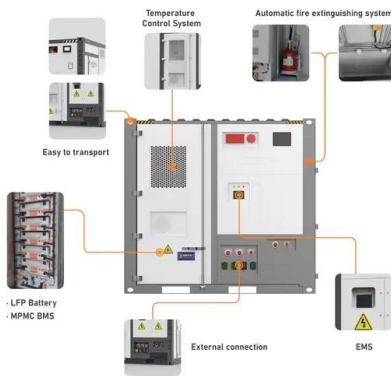

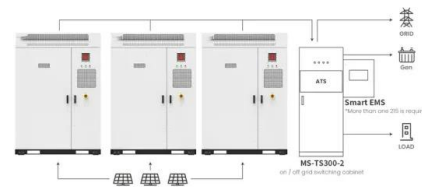
