RESIDENTIAL: \$500 OR DOUBLE THE PERMIT FEE (WHICHEVER IS GREATER)

COMMERCIAL: \$1000 OR DOUBLE THE PERMIT FEE (WHICHEVER IS GREATER)

\*\*\*Please Note, All work in Commercial locations requires a building permit.

AB 1124 decreases the permit fees local building departments can charge for solar energy systems. Except as provided in paragraph (2), for photovoltaic systems, that fee shall not exceed four hundred fifty dollars (\$450) plus fifteen dollars (\$15) per kilowatt for each kilowatt above 15kW. These practices made installing solar less expensive and increased expansion of this technology in California.
