

Solar container three exemptions and three halvings





Overview

This video explains the eight exemptions in the revised Common Rule, focusing specifically on exemptions 1, 2, 3, and 5. But here's the kicker: understanding these policies could mean the difference between a profitable energy storage project and one that gathers dust like last year's solar forecasts. Lessee's sale of the Energy Storage System to the Lessor is exempt from sales tax as a casual and isolated sale under G. Starting January 1, 2026, new Foreign Entity of Concern (FEOC) rules take effect. Since that time, the Texas Legislature has enacted and sub-sequently amended Tax Code Section 11.

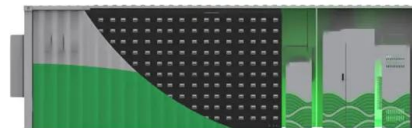
