

The guardrail outside the window can store electricity





Overview

11 of the New York City Mechanical Code (MC) require guard railings ('guards') to be provided where components of a mechanical system, mechanical equipment and mechanical devices requiring service are located. When guardrail systems are used at hoisting areas, a chain, gate or removable guardrail section shall be placed across the access opening between guardrail sections when hoisting operations are not taking place. To clarify the use of guards and personal fall arrest systems to facilitate solar panel maintenance. An important exception exists when working above dangerous equipment, such as chemical vats or electrical machinery, where protection is required regardless of height, since these hazards can cause serious injury upon contact. Additionally, stairways with 4 or more steps must have a stair rail system with a handrail.

When reinstalling or rebuilding a guardrail, make sure it is installed as intended according to the manufacturer's instructions or its original design. Store the removed guardrails or sections in a ...

Guard Rail Code Compliances

If a 42" guard is needed (for commercial or per local code), the guardrail is essentially identical except the posts and balusters are a bit taller. The 4" maximum spacing rule still applies up to the full 42" ...

SECTION 21

4 ft (1.2 m) or more above adjacent floor or ground level shall be guarded by a guardrail system (or equivalent) along all open sides (except where there is an entrance to a ramp, stairway or fixed ...



GUARDRAIL 101

The guardrail can operate to deflect a vehicle back to the roadway, slow the vehicle down to a complete stop, or, in certain circumstances, slow the vehicle down and then let it proceed past the guardrail.

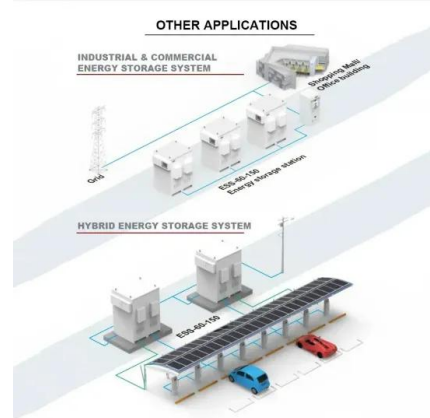
Four Important IBC Code Requirements for Guardrails

IBC 2407.1.2 states that every guardrail must be supported by at least three glass balusters. It also states that there should be adequate support so that the guardrail remains firmly in ...



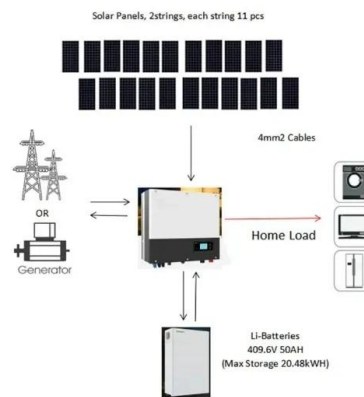
