Beginning January 1, 2026, new Foreign Entity of Concern (FEOC) compliance rules will fundamentally change how U. solar and storage projects qualify for federal incentives — and reshape project economics across the commercial and industrial energy market. A major change is coming for commercial solar projects — and it could determine whether your company qualifies for the federal 30% Investment Tax Credit (ITC) for solar or loses it entirely. 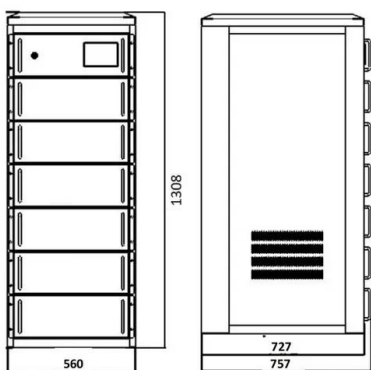

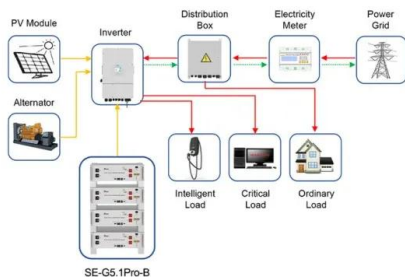
