Overview

The legal approval process for solar projects begins with a comprehensive application submitted to relevant authorities. This application must include detailed project descriptions, site plans, environmental impact assessments, and technical specifications. In 2011, California adopted a Renewable Portfolio Standard (RPS) requiring that at least one-third of the state's electricity come from clean energy sources by 2020. The California RPS program was established in 2002 by Senate Bill (SB) 1078 (Sher, 2002) with the initial requirement that 20% of.
